EPP ANNUS holds a PhD in Estonian literature (2002). She works as a senior researcher with the Cultural Theory Group of the Estonian Literary Museum. Her publications include a monograph on time and narrative Kuidas kirjutada aega (2002), a novel Matilda (2007), an edited collection 20. sajandi mõttevoolud (2009). She coordinates the international research group "Heterologies of the Everyday". She has taught at Tartu University, Tallinn University, Turku University and Ohio State University. Her fields of interest include twentieth-century Estonian prose fiction, Soviet postcolonial studies, and the phenomenology of the everyday.

CAROLINE ANTHERIEU-YAGBASAN took a double degree, Classical Studies and Philosophy, specializing in the philosophy of art. She has participated in the international conference *L'Art du Portrait* (University of Agadir, April 2012, proceedings published by Presses académiques européennes). She is working on a thesis about the creation of Stefan Zweig's characters and is a member of the research group CEPERC (Université Aix-Marseille). She teaches French, ancient Greek and Latin. She is a co-author of a book about Philosophers and the First World War.

WITHOLD BONNER is Senior Lecturer for literature and culture of the German speaking countries at the University of Tampere (Finland). His areas of specialization include GDR literature, autobiographical writing, memory as well as transcultural literature and film. Form 2004 to 2008 he participated in the NordForsk project Autobiographical Writing in Contemporary German Literature. Currently he is partner of the project Finnish-German literary and cultural contacts, run by the University of Vaasa (Finland) and is member of the project Water as Cultural Space: Changing Values and Representations, funded by the Finnish Academy of Sciences. In 2001 he defended his doctoral thesis on Der Vogel mit dem bunteren Gefieder. Redevielfalt als Maskerade in der Prosa Brigitte Reimanns. Together with Arja Rosenholm he is co-editor of the conference proceedings Recalling the Past – (Re)constructing the Past. Collective and Individual Memory of World War II in Russia and Germany (2008) and together with Ewald Reuter co-editor of the conference proceedings of the triennial conference of Finnish scholars of German philology Umbrüche in der Germanistik (2011).

BIRGIT DAHLKE is Visiting Professor of German Literature at Humboldt University Berlin. Her research interests include modern and contemporary German literature, with particular foci in gender and canonization, life writing, interdependences of race, gender and age, German unification, and literary and cultural life of East(ern) Germany. She is the author of the monographs Wolfgang Hilbig. A Biography (2011); Jünglinge der Moderne. Jugendkult und Männlichkeit in der Literatur um 1900 (2006) and Papierboot. Autorinnen aus der DDR - inoffiziell publiziert (1997) and co-editor of books German Life-Writing in the Twentieth Century with Dennis Tate and Roger Woods (2010); Kerstin Hensel, Contemporary German Writers with Beth Linklater (2002); Zersammelt. Die inoffizielle Literaturszene der DDR nach 1990. Eine Bestandsaufnahme with Roland Berbig, Michael Kämper-van den Boogaart and Uwe Schoor (2001); LiteraturGesellschaft DDR. Kanonkämpfe und ihre Geschichte(n) with Martina Langermann and Thomas Taterka (2000) and the biannual journal for new literature, essays and criticism Moosbrand. neue texte with Klaus Michael, Lutz Seiler and Peter Walther (1996-1999).

JAVIER GÓMEZ-MONTERO is the Professor of Literature and Romance Studies and director of the Department of Romance Languages and Literature at Kiel University (CAU), Germany, and director of the Centre for the Study of Spanish Renaissance in its European context as well (CERES: www.uni-kiel.de/ ceres). Since October 2007, he is also in charge of the Centre for Galician Studies (CEG: www.uni-kiel.de/ceg). He directs the Literary Translation Workshop (TTL) at Kiel University and edits a publication series at Verlag Ludwig. He has published several studies on cultural anthropology, and he works on The Way of St. James, as well as on anthologies of literary texts about it. From 2010 until 2012 he coordinated the Intensive Programme (IP) URBES EUROPAEAE (www.uni-kiel.de/urbes.europaeae), as well as the activities related to the projects "Cultures and Languages on the Route of Santiago de Compostela" (www. camino-eu.com/) and "University and School towards a European Literary Canon" (www.uni-kiel.de/elica) in Germany, both supported by the Education, Audiovisual and Culture Executive Agency (EACEA) of the European Union. Prof. Gómez-Montero's research focuses on modern and contemporary poetry, Renaissance fiction, as well as Cervantes' works.

MAARJA HOLLO has an MA in Estonian Literature and she is working on the dissertation *Autobiographism and Representations of Exile and Remembering in Bernard Kangro's Work*. She is a researcher at the Estonian Cultural History Archives of the Estonian Literary Museum. She has published articles on Bernard Kangro's works in the magazines *Keel ja Kirjandus, Methis*, and in

the collection *Haunted Narratives*. Life Writing in and Age of Trauma (University of Toronto Press, 2013). She is interested in problems related to the autobiographical, the depiction of remembering in Estonian literature in exile and life writing of diaspora Estonians.

BENEDIKTS KALNAČS is Deputy Director of the Institute of Literature, Folklore, and Art at the University of Latvia, Riga, and Professor at the University of Liepāja. He is co-editor of 300 Baltic Writers: Estonia, Latvia, Lithuania (Vilnius, 2009), Back to Baltic Memory: Lost and Found in Literature 1940–1968 (Riga, 2008), We Have Something in Common: The Baltic Memory (Tallinn, 2007), Ibsen in Poland and the Baltic Nations (Oslo, 2006), and editor and author of several books in Latvian, most recent among them Postkoloniālā Baltijas drāma (Riga, 2011).

KATRIN KANGUR is a post-graduate student of Comparative Literature at Tartu University, Institute of Culture Studies and Arts. She graduated in 2006 with a bachelor degree in the Danish language and literature and continued with MA studies in comparative literature. Her background and interests thus lie in both comparative literature and Scandinavian studies, recently especially in non-fictional aspects of literature and film.

ANNELI KÖVAMEES took her PhD in literary studies with a thesis about Italy in Estonian travelogues (*Itaalia eesti reisikirjades: Karl Ristikivi "Itaalia capriccio" ja Aimée Beekmani "Plastmassist südamega madonna"*, 2008, Tallinn University). She works at the Tallinn University (lecturer at the Institute of Estonian Language and Culture, researcher at the Institute of Slavonic Languages and Cultures). Her main research interests are Estonian literature, Estonian travelliterature (travelogues), imagological literary research, national images and stereotypes in literature.

REBEKKA LOTMAN is a doctoral student at the Institute of Cultural Research and Fine Arts, University of Tartu, and her research focuses on Estonian poetry, especially the sonnet in comparative perspective. She works as a managing editor at the Tallinn University Press.

LIINA LUKAS is Associate Professor for Comparative Literature at the Institute of Cultural Research and Fine Arts at the University of Tartu and Senior Reseacher of the Estonian Academy of Sciences. Her research interests are Estonian-German literary contacts, Baltic-German literature and early Estonian literature. She heads the Research and Web Project of Baltic Literary

Culture – EEVA, supported by the Estonian Science Foundation, which studies and offers, in digital format, international access to old cultural texts, written or published in the Baltic cultural space (www.utlib.ee/ekollekt/eeva). She is a member of Board of the international Vladimir-Admoni-Doktorandenschule at the University of Latvia; chairwoman of the Goethe-Gesellschaft in Tartu; member of the Estonian Association of Comparative Literature, of the Estonian Literary Society, of the International Association for German Studies, of the Academic Advisory Board of Interlitteraria and of the Editorial Board of the yearbook of German studies Triangulum.

ARNE MERILAI is Professor and Chair of Estonian Literature (2011) of the University of Tartu, former associate professor of literary theory. At present, his primary area of research is national literature in the context of world literature informed by a comparative poetics and "unified field theory" for literary studies. Primarily, his researches are anchored in bio-bibliographical and comparative historical traditions, formal poetic analysis, linguistic and close-reading criticism, literary psychoanalysis and phenomenology. In addition, he has developed an innovative approach called "pragmapoetics", a philosophy of poetic language usage rooted in analytical philosophy. His book Eesti ballaad 1900-1940 was published in 1991, and Eesti pagulaskirjandus 1944–1992: Luule (with Õnne Kepp) in 1994. Eesti ballaad: Antoloogia: XVII-XX sajand, Poeetika: Gümnaasiumiõpik (with Anneli Saro and Epp Annus), and Pragmapoeetika: Kahe konteksti teooria were released in 2003. Besides editing the joint research books, he has published two volumes of his own selected articles, Vokimeister: Kriitilisi konstruktsioone 1990-2011 (2011), and Õnne tähendus: Kriitilisi emotsioone 1990-2010 (2011). A member of the Estonian Writers' Union, he penned two collections of poetry, Merlini aare (1998) and Tolmutort (2001), a play (2006), and a novel Türann Oidipus (2009). With about 250 publications to his credit, professor Merilai ranks among the most prolific leading scholars in Estonia.

DIETER NEIDLINGER is assistant lecturer at the German Department of the University of Tartu; he also works as a free lance author and publisher for educational books (especially German as a foreign language). His research interests include modern and contemporary (German) literature, interculturality and (literary) translation, literary and cultural didactics in foreign language learning, poetics of remembrance. Together with Silke Pasewalck and Terje Loogus he is the co-editor of the conference proceeding *Interkulturalität und (literarisches) Übersetzen* (Stauffenburg, Tübingen, being published in 2014).

SILKE PASEWALCK is Guest Associate Professor at the German Department of the University of Tartu since 2010. She worked as a lecturer at the Nikolaus-Kopernikus-University in Toruń (Poland) from 2000 to 2005. She took her PhD in 2002, with the monograph 'Die fünffingrige Hand'. Die Bedeutung der sinnlichen Wahrnehmung beim späten Rilke (Berlin: De Guyter). Her research interests include modern and contemporary (German) literature, literary interculturality and multilinguality, literary and cultural didactics in foreign language learning, poetics of remembrance, literature and nation building. Together with Heinrich Detering, Torsten Hoffmann and Eve Pormeister she is the co-editor of the conference proceedings Nationalepen zwischen Fakten und Fiktionen (Humaniora: Germanistica 5, Tartu, 2011) and together with Dieter Neidlinger and Terje Loogus of Interkulturalität und (literarisches) Übersetzen (Stauffenburg, Tübingen, being published in 2014).

PIRET PEIKER is an Estonian literary scholar and translator. She is working on a doctoral thesis in Comparative Literature at the University of Turku and is teaching at the Estonian Institute of Humanities, Tallinn University. Her research interests include genre poetics, nationhood, postcolonialism and modernity.

EVE PORMEISTER is Associate Professor for literature of the German speaking countries at the University of Tartu. Her areas of specialization include literature of German-speaking Switzerland as well as Austrian and German literature, literature of writing women, memory and motive of death. She took her PhD in 2003, with the thesis Bilder des Weiblichen in der deutschsprachigen Frauenliteratur. In addition to many articles and some afterwords to books she has published the book Grenzgängerinnen. Gertrud Leutenegger und die schreibende Nonne Silja Walter aus der Schweiz (Berlin: Saxa Verlag, 2010). She has also published and edited several collective works, for example the conference proceedings Ingeborg Bachmann. ,Die Wahrheit ist dem Menschen zumutbar' (Humaniora: Germanistica 2, Tartu, 2007) and Tradition und Moderne in der Literatur der Schweiz im 20. Jahrhundert (Humaniora: Germanistica 4, Tartu, 2008) together with Hans Graubner. Together with Silke Pasewalck, Torsten Hoffmann, Heinrich Detering she is co-editor of the conference proceedings Nationalepen zwischen Fakten und Fiktionen (Humaniora: Germanistica 5, Tartu, 2011). From 2007 to 2012 she participated in the research project World literature in Estonian Culture. Estonian Literature in World Literature (the Historical and Contemporary Paradigm) led by Professor Jüri Talvet, and from 2002 to 2003 in the research project *Linguistic* 

and Cultural-Psychological Aspects of Communication in the Changing World led by Professor Krista Vogelberg.

AIJA SAKOVA-MERIVEE has an MA in German Literature from Tartu University and has also studied at Humboldt University in Berlin and at Vienna and Konstanz universities. She has published articles on Ene Mihkelson's, Christa Wolf's and Ingeborg Bachmann's writings. Her fields of interest include the poetics of remembrance, life writing, moral witnessing and philosophy of literature. Her doctoral dissertation is a comparative study on remembrance metaphors and on the issues of moral witnessing in the novels of Ene Mihkelson and Christa Wolf.

MONICA SPIRIDON, Professor, Faculty of Letters, University of Bucharest, Romania, specializes in comparative literature, literary theory, cultural and media studies. Author of 18 books of comparative literature and East-Central European intellectual history of the twentieth century, published inside and outside Romania, of approximately 140 academic studies published in scholarly periodicals and of two dozen chapters in books published in Europe, Canada and the U.S. Vice-president of the International Comparative Literature Association (since 2010); president of the ICLA Research Committee on Eastern and South-Eastern Europe (2000–2009); founder of the European Network of Comparative Literary Studies (ENCLS), member of the Executive Bureau (2003–2007); chair to the Experts Panel for Literature of the European Science Foundation (ESF); member of Academia Europea (The Academy of Europe).

JÜRI TALVET is since 1992 Chair Professor of Comparative Literature at the University of Tartu. He took his PhD on the Spanish picaresque novel at Leningrad University in 1981. He has published in Estonian collections of essays Hispaania vaim (1995), Tõrjumatu äär (2005), cultural-philosophic reflections Sümbiootiline kultuur (English title A Call for Cultural Symbiosis, 2005), books of (travel) essays Teekond Hispaaniasse (1985, Estonia's annual literary prize in essay genre), Hispaaniast Ameerikasse (1992), Ameerika märkmed ehk Kaemusi Eestist (2000) and eight books of poetry. His books of poetry and essays have been translated into English, Spanish, French, Catalan, Romanian and Italian. In 1997 he was awarded the Juhan Liiv Prize of Poetry and in 2002 the Ivar Ivask Memorial Prize for poetry and essays. He has translated into Estonian both classical and modern works (Quevedo, Gracián, Calderón, Tirso de Molina, Espriu, Aleixandre, García Márquez, etc.) and has edited a major anthology of US poetry in Estonian translation (2008). He is the editor and principal author of a manual of world literature for Estonian high

schools and universities (*Maailmakirjandus*, I–II, Tallinn 1995–1999). In 2012 his monograph on Juhan Liiv's poetry (*Juhan Liivi luule*) was published. He has chaired the Estonian Association of Comparative Literature (1994–2010) and has also served as member of the ICLA Executive Committee (2000–2007).

OLAVI TEPPAN is currently a PhD student at the Department of Comparative Literature at Tartu University where he earned a BA degree in history in 1999. He has since worked as a translator and publisher. His translations into Estonian include American and British prose such as Cat's Cradle by Kurt Vonnegut, Manhattan Transfer by John Dos Passos, Trainspotting by Irvine Welsh, Naked Lunch by William Burroughs, Crash by J. G. Ballard, etc. As a publisher, he has started the fiction series Ajavaim which is dedicated to influential works of world literature previously not translated into Estonian.

JAAN UNDUSK, a graduate of Tartu University (PhD 1986), is since 2000 the director of the Under and Tuglas Literature Centre, a research institute of the Estonian Academy of Sciences in Tallinn. Among his interests are the philosophy of language and literature, German life and letters in the Baltics, the rhetoric of history writing. He has written a large number of articles and essays on Estonian, Baltic German and German authors, as well as translated works of Friedrich Nietzsche, Emmanuel Lévinas, Meister Eckhardt, Thomas Bernhard and others. As a writer, he has published a novel, plays and short stories. In 1995 he was awarded the International Herder Prize for literary research by the Vienna University. He is a member of the Estonian Academy of Sciences (2007) and Baltic History Commission in Göttingen (2008).
