

## *About the Authors*

KNUT BRYNHILDSVOLL is Professor of Nordic Literature at the University of Cologne; Guest professor at the universities in Hamburg, Bochum, Marburg, Giessen and Zürich. From 2000 to 2007 he was the director of The Centre for Ibsen Studies, University of Oslo. He has published over 200 articles in national and international research journals on topics from romantic literature to postmodernity, including literary theory and comparative literature, and numerous scientific books in Norwegian and German.

YOLANDA CABALLERO ACEITUNO is Assistant Professor in the Department of English Philology of the University of Jaén (Spain), where she completed her doctorate with a thesis on Laurence Sterne's narrative. She has published several articles on this author, eighteenth-century English literature and the theory of cultural semiotics, which also comprise some of her main research interests. She has also been engaged in two research projects about the representation of Muslims, Jews and Spaniards in Early Modern English writings and is also studying the conflicts of identity as reflected in the works by some late seventeenth and eighteenth-century women writers.

ANNE-MARIE LE BAILLIF taught French literature at the University Paris Est Créteil until 2010. Since then she has worked on political topics in literature. She has studied 16<sup>th</sup>-century theatre and 20<sup>th</sup>-century novels that developed national languages in new nation states, like Estonia or Norway. Her present research is focused on A. H. Tammsaare's novel *Tõde ja õigus* (in French translation *Vérité et justice*). She is the author of a work titled *Jean Virey du Gravier, Tragédies* (Champion, 2013) and has published articles in journals (*Grandes figures historiques dans les lettres et les arts, Nordlit, Image et Narrative*).

JONATHAN LOCKE HART is Chair Professor, Creative Writing, Comparative Literature, Theory, and Literature in English and Director, Centre for Creative Writing and Literary Translation and Culture at Shanghai Jiao Tong University. He is also Core Faculty in Comparative Literature at Western University and Life Member, Clare Hall, University of Cambridge. A Fellow of the Royal Society of Canada, he is a poet, writer of other genres, literary scholar and historian who studied at Toronto and Cambridge and has held visiting appointments at Harvard, Cambridge, Princeton, Toronto, the Sorbonne Nouvelle (Paris III) and elsewhere. The author of many articles and over twenty books, including *Theater and World* (1992), *Northrop Frye: The Theoretical Imagination* (1994),

*Representing the New World* (2001), *Contesting Empires* (2005), *Interpreting Culture* (2006), *Empires and Colonies* (2008), *Shakespeare: Poetry, History and Culture* (2009), *Shakespeare and His Contemporaries* (2010), *Literature, Theory, History* (2011), *Fictional and Historical Worlds* (2012) *Textual Imitation* (2013), *From Shakespeare to Obama* (2013), and *The Poetics of Otherness* (2015). He has two books under contract and a number of articles or chapters on Ted Hughes, comparative literature, world literature, translation, poetics, theory and other topics. His most recent book of poetry is *The Burning Lake* (2016).

MIRUNA IACOB is a third-year PhD student at the Faculty of Letters of Transilvania University of Braşov, Romania. Some of her research interests concern theories of humor, functions of humor in Romanian literature during communism, post-communist Romanian writings, intercultural dialogues, the subversive nature of humor within a totalitarian regime, communism and postmodernism. She has published articles on totalitarianism and dystopian literature, on humor theories, and gender issues in Romanian literary magazines.

MAIRE JAANUS is Professor of English and Comparative Literature at Barnard College and the Columbia School of Graduate Studies, and the author of *Kirg ja kirjandus: esseid eesti ja Euroopa kirjandusest ja psühhoanalüüsist* (*Literature and Passion: Essays on Estonian and European Literature and Psychoanalysis*, 2011), *She – a Novel* (1984), *Literature and Negation* (1979), *Georg Trakl* (1974); co-editor of *Culture and Clinic: We Are All Mad Here*, Vol. I (2013); *Lacan in the German-Speaking World* (2004), *Reading Seminar XI: Lacan's Four Fundamental Concepts* (1996) and *Reading Seminars I and II: Lacan's Return to Freud* (1995). Recent articles on Camus, Hamlet, Lispector, Tolstoy, and Plato have appeared in *Literature in Contexts*, *Lacanian Interpretations of Shakespeare*, *Psychoanalytical Notebooks*, *Lacanian Compass*, and *Socrates: Reason or Unreason as the Foundation of European Identity*.

KAN CHIA-PING is Professor of French at the National Central University of Taiwan. She has published a series of articles on Balzac in international journals. Since 2012, she works on comparative studies between *The Human Comedy* and *Dream of the Red Chamber*, one of the four classics of Chinese literature, and has published two articles in this area.

FLORENCE KUEK is an editorial assistant of *International Journal of Diaspora & Cultural Criticism*. She is currently working on her doctorate research at the Chinese Studies Department, University of Malaya. Her research foci include literary criticism and modern literature. Her recent published articles

in peer-reviewed indexed journals include “Rosalie or not Rosalie: Han Suyin’s ethical identity and ethical choices in the Crippled Tree series” (*Forum for World Literature Studies*, 2014); “An Appeal for Legitimacy: A Reflection on the Autobiographies of Pearl S. Her publications include the articles “Politics Field and the Humane Requirements of Chinese Literary Theory” (*Chinese Language and Literature Research*, 2015) and “Power, Tool and Imagination: Three Dimensions of Jack Zipes’s Criticism on Fairy Tales” (*Literature and Art Criticism*, 2016).

LING TEK SOON is a senior lecturer at the Institute of China Studies, University of Malaya. Apart from teaching, he is currently engaged in the research project *Abode of Dead, Depository of Knowledge and Contested Realm: A Study of Chinese Cemeteries in Malaya*. He has published a number of articles in international journals, such as *Foreign Literature Studies*, *Universitas*, *East Asia: An International Quarterly*.

AGNIESZKA ŁOBODZIEC is Assistant Professor and the head of the Section of Literature of the English Speaking World, English Department, University of Zielona Gora, Poland. She is the author of *Black Theological Intra-racial Conflicts in the Novels of Toni Morrison* (2012) and *From Oppressive Patriarchy to Alternative Masculinity: Black Men and Violence in Womanist Novels* (2016).

ANNELI MIHKELEV, Tallinn University, PhD in Semiotics and Cultural Studies at the University of Tartu with the monograph *Vihjamise poeetika* (‘The Poetics of Allusion’) (2005). She works as a Senior Researcher in Tallinn University, current research project *Estonia between East and West: the Paradigm of “Own”, “Other”, “Strange”, “Enemy” in Estonian Cultures at the End of the 19<sup>th</sup> and in the 20<sup>th</sup> Century*. Her fields of research include Estonian literature, allusions in literature and culture, and comparative literature (mainly Baltic literatures). She has published articles on these topics in international and Estonian publications. She is also an editor of the reference guide to authors and their works *300 Baltic Writers: Estonia, Latvia, Lithuania* (2009), and the collections of articles *We Have Something in Common: the Baltic Memory* (2007) and *Turns in the Centuries, Turns in Literature* (2009).

BĀRBALA SIMSONE is a literary scientist, one of the leading specialists in Latvia regarding genre fiction. Her doctoral thesis (2007) was devoted to the mythological aspects of English and Latvian fantasy prose. She has published two books: *Geography of the Imagination: Mythical Paradigm in English Fantasy Prose* (2011) and *Monsters and Metaphors: Insight in the World of Horror Fiction* (2015). Her research papers have been published in Latvian, Lithuanian, Estonian, Polish and Danish academic editions. Her research interests concern genre fiction (especially fantasy, science fiction and horror genres), gender studies and Latvian original fiction. Mrs Simsone regularly publishes book reviews in the most prominent culture press editions of Latvia. She works in the publishing house Zvaigzne ABC Publishers as the Head of Department for Latvian Language and Literature.

KATRI SIRKEL has a Bachelor's degree in English Language and Literature and a diploma in English language teaching from the University of Tartu (both 2000) and a Master's degree in English Language and Literature from the University of Tartu (2005). Since 2009 she is enrolled in the doctoral programme of Germanic and Romance languages and literatures at the University of Tartu, where she was also Assistan Lecturer at the Department of English from 2002 to 2013. Since 2013 she is lecturer of English at the Estonian National Defence College.

ANA TOROŠ is Assistant Professor at the School of Humanities and a research fellow at the Research Centre for Humanities (University of Nova Gorica). Her main research and teaching domain is literature along the border between Slovenia and Italy. In this regard it is important to note her postdoctoral research fellowship in 2009 that she received by the Consorzio per lo Sviluppo Internazionale dell'Università di Trieste for further research of the poetry of the Trieste region. In 2011 she brought out a monograph (*The Image of Trieste and Its Surroundings in the Slovenian and Italian Poetry of the First Half of the 20<sup>th</sup> Century*) and received an award by the Republic of Slovenia Government's Office for Slovenians Abroad. WANG TIAO is associate professor in English at School of Foreign Languages in Harbin Institute of Technology, China. She got her PhD in English Language and Literature in 2014 from Shanghai International Studies University. She was a visiting scholar in Durham University in UK from 2012 to 2013. Her research interests cover comparative literature and world literature, especially fiction studies. She has published 13 papers in different Journals, such as *Foreign*

*Language Studies*. Her translation of Ronald Schleifer's *Pain and Suffering* into Chinese was published in 2017.

INDRĖ ŽAKEVIČIENĖ, Dr. Phil., is Associate Professor at the Department of Lithuanian Studies at Vytautas Magnus university. In 2006 she gained her master degree in Psychology and after that expanded her field of interest – became interested in interdisciplinary comparative studies.
