LEENA KÄOSAAR is an Associate Professor of Cultural Theory at the Institute of Cultural Research, University of Tartu, Estonia. Her research focuses on life writing, memory studies, and trauma, especially in the context of Stalinist repressions, the Estonian Western diaspora, and women's life narratives. She has widely published on these subjects, with particular attention to the representation of traumatic experience, relationality, dynamics of address, travelling memory, and gender. Her work also engages with creative nonfiction and life story writing, which she teaches at the University of Tartu. She is co-editor of several volumes and special issues, including *Aino Kallas: Negotiations with Modernity* (SKS, 2010, with Lea Rojola), *Border Crossings: Essays in Identity and Belonging* (Routledge, 2020, with Paul Longley Arthur), *Narrating Migration and Diaspora* (special issue of *Trames*, 2019, with Triinu Ojamaa and Aija Sakova), and two special issues of *Folklore on Migration and Diasporas* (2020) and *Trauma* (2021, with Sergey Troitskiy and Liisi Laineste). As part of her engagement with applied memory studies and narrative practice, Käosaar also works on the collection and documentation of life stories of Ukrainian refugees in Estonia within the framework of the project "Taking Shelter in Estonia: the Stories of Ukrainians Fleeing from the War."
