ANDREI BODIU, Romanian writer and literary historian. He is a Chair professor, PhD advisor and dean of the Faculty of Languages and Literatures at Transylvania University of Brasov. He has published books of poetry, prose, literary criticism and history of Romanian literature. His main works are: Pauza de respiratie ('Breathing Pause'; with Simona Popescu, Caius Dobrescu and Marius Oprea, 1991), Cursa de 24 de ore ('The 24 Hours' Race',1994), Poezii patriotice ('Patriotic Poems',1995), Studii pe viata si pe moarte ('Studies on Life-Tired People", 2008; poetry), Bulevardul eroilor ('Hero's Boulevard', 2004; novel), Directia optzeci in poezia romana ('The Direction of the 80s in Romanian Poetry', 2000), Sapte teme ale romanului postpasoptist ('Seven Themes of the Romanian Post 1848 Novel', 2002; history of literature). Samples of his poetry have appeared in translation in English, German, French, Russian, Polish, Portuguese, Slovenian, Czech, Hungarian, Latvian. He has received several national awards for his poetry and for his critical works, like ASPRO prize for poetry in 2000 for Studii pe viață și pe moarte (Studies on Life and Death) and the Romanian Writer's Union award for poetry in 2009 for Oameni obosiți (Tired People).

MAIJA BURIMA, PhD, Professor at the Comparative Studies Institute and head of the Department of Latvian Literature and Culture, Daugavpils University, and researcher at the Institute of Literature, Folklore, and Art of the University of Latvia (Riga). She has published academic monographs: *Ibsens Latvijā* [*Ibsen in Latvia*]. Riga: Norden AB, 2007, 648 pp.; *Modernisma koncepti* 20. gadsimta sākuma latviešu literatūrā [Concepts of Modernism in Latvian literature at the beginning of the 20<sup>th</sup> century], Rīga: Latvijas Universitāte, Literatūras, folkloras un mākslas institūts, 2011, 328 pp., and more than 120 articles in Latvian, English, Russian, Estonian, Lithuanian. Her research interests include comparative literature in the wide cultural context, Avant-Garde and Modernism studies, writing and identity, travel literature, comparative Latvian literature.

CAIUS DOBRESCU is Professor at the Bucharest University (Theory of Literature Department). Among other research interests, he authored books on literature and politics in the Communist and post-Communist social environments, as well as on aspects of literary modernity: *Modernitatea ultimă* (The

ultimate modernity, 1998), Inamicul impresonal (The impersonal enemy, 2001), Semizei şi rentieri (Demigods and rent-seekers, 2000), Revoluția radială (The radial revolution, 2008). With Andrei Bodiu he contributed to the collection of studies Dea Munera. On the literary representation of corruption in the European modernity (2007). He was granted a Herder scholarship at the Vienna University and was a Fellow of institutes for advanced studies such as New Europe College, Romania, and Budapest Collegium, Hungary. As a Fulbright scholar affiliated with the Committee on Social Thought of the University of Chicago he conducted research on terrorism and the literary modernity. He is also the author of four books of poetry and three novels.

DOROTHY FIGUEIRA is Professor in Comparative Literature at the University of Georgia, USA. Trained in both comparative literature and the history of religions, she is interested in the intersection of religion and literature. Her research includes: Translating the Orient (1991), The Exotic; A Decadent Quest (1994), Aryans, Jews and Brahmins: Theorizing Authority through Myths of Identity (2001) and Otherwise Occupied: Theories and Pedagogies of Alterity (2008). She has recently completed a volume on early European travel narratives to India. She has held positions at Cornell University, SUNY, University of Illinois; has been a visiting professor at Indiana University and the University of Lille. She has been the recipient of several Fulbrights to India. She holds degrees from the Ecole Pratique en Sciences Sociales, Harvard University, the University of Chicago. She has served as president of the ICLA. Professor Figueira has served also as editor of *The Comparatist* and is currently editor of Recherche litteraire/Literary research, the review journal of the ICLA. She has edited several books including most recently with Marc Maufort, Theaters in the Round (2011).

EVA EGLĀJA-KRISTSONE holds PhD since 2007 and is a researcher at the Institute of Literature, Folklore, and Art at the University of Latvia, Riga. She is a co-editor of Back to Baltic Memory: Lost and Found in Literature 1940–1968 (Riga, 2008), one of the authors and editors of 300 Baltic Writers: Estonia, Latvia, Lithuania (Vilnius, 2009) and collective monography Latvieši, igauņi un lietuvieši: literārie un kultūras kontakti (Latvians, Estonians and Lithuanians: Literary and Cultural Contacts. Riga, 2008). Her own monography Dzelzsgriezēji. Padomju Latvijas un trimdas latviešu rakstnieku kontakti (Iron Cutters. Contacts between Writers in Soviet Latvia and the Latvian Diaspora. Riga,

2012) is a study on Latvian cultural contacts and the role of literature on both sides of the Iron Curtain during the Cold War.

LADISLAV FRANEK is Professor at the Department of Romance Languages and Literatures, Faculty of Philosophy, Constantine the Philosopher University in Nitra, and a researcher at the Institute of World Literature, Slovak Academy of Sciences in Bratislava, Slovakia. His teaching and research spans several disciplines: literary history and theory, comparative literature, stylistics and literary translation. His main research interest is in the function of the rhythm of languages. Main publications: The Style of Translation. A Developmental-Theoretical Analysis of Slovak Translations of Paul Claudel (1997); The Modernity of Romance Literatures (2005). He is the author of many theoretical-critical studies on Slovak literary translations from Romance languages. He has translated over 20 works from French, Portuguese, and Spanish (Premium in Literary Fund's Ján Hollý Award for the translations of M. Yourcenar: Memoirs of Hadrian, 1990; P. Claudel: Annunciation. In: Plays 2007). He works with all literary genres. He is the recipient of the Honorary Plaque for his achievement in the Social Sciences (2008) by the Slovak Academy of Sciences.

KATILIINA GIELEN is assistant lecturer at the Department of English Language and Literature, Institute of Germanic, Romance and Slavonic Languages, University of Tartu. She is a PhD candidate in translation studies. Her research interests include translation history, theory and practice, comparative literature as well as gender studies.

JEANNE E. GLESENER holds a PostDoc post for Luxembourgish Literature at the University of Luxembourg. She earned her PhD in Comparative Literature at the Université de Provence and her thesis focused on the aesthetics and the reception of contemporary migrant literature in Great-Britain, Germany and Luxembourg. Her fields of scientific research are Luxembourgish literature, postcolonial and migrant literatures, the history of comparative literature and the crime novel among others. She currently works on the representation of steel industry in Luxembourgish Literature and participates in an international research project on migration and literature in contemporary Europe.

AIGI HEERO is Lecturer at the Department of German Language of the Tallinn Pedagogical University. She defended her PhD in 2001 at the University of Freiburg (Germany). Her research interests include German literature

of the 19<sup>th</sup> century, literary expressionism, contemporary German literature and relations between arts (literature, music and painting).

RODICA ILIE is Senior Lecturer, PhD, Head of Romanian Language Department, Transylvania University of Brasov, Romania. Areas of competence: Literary Theory, Comparative Literature, Theory and Poetics of Avant-Garde. She has published the following books: Manifestul literar. Poetici ale avangardei în spațiul cultural romanic, [Literary Manifesto. MARKO JUVAN is Senior Researcher and head of the Institute of Slovenian Literature and Literary Studies (Research Centre of the Slovenian Academy of Sciences and Arts) and Professor of Slovenian Literature at the University of Ljubljana. His current areas of interest include literary discourse, intertextuality, Slovenian literature and world literary system, cultural nationalism in romanticism, and spatial literary studies. He is in editorial boards of Primerjalna književnost, CLCWeb, Context and Slavica litteraria and co-edits the series "Studia litteraria." 2002-06 he was president of the Slovenian Comparative Literature Association, 2007-11 member of the Executive Committee of the REELC/ENCLS, since 2008 he is in the ICLA Committee on Literary Theory. His recent publications include three books and one edited volume: Literary Studies in Reconstruction: An Introduction to Literature (Frankfurt/M. etc.: Peter Lang, 2011), History and Poetics of Intertextuality (West Lafayette, IN: Purdue University Press, 2008), Literarna veda v rekonstrukciji (Ljubljana: LUD Literatura, 2006), Primerjalna književnost v dvajsetem stoletju in Anton Ocvirk (Comparative Literature in the 20th Century and Anton Ocvirk), ed. by Marko Juvan and Darko Dolinar (Ljubljana: Založba ZRC, 2008).

BENEDIKTS KALNAČS is Deputy Director of the Institute of Literature, Folklore, and Art at the University of Latvia, Riga, and Professor at the University of Liepāja. He is co-editor of 300 Baltic Writers: Estonia, Latvia,

Lithuania (Vilnius, 2009), Back to Baltic Memory: Lost and Found in Literature 1940–1968 (Riga, 2008), We Have Something in Common: The Baltic Memory (Tallinn, 2007), Ibsen in Poland and the Baltic Nations (Oslo, 2006), and editor and author of several books in Latvian, most recent among them Postkoloniālā Baltijas drāma (Riga, 2011).

MERILIN KOTTA is a translator and a lecturer of Catalan culture at Tallinn University. She took her MA in Spanish studies at Tartu University (2007). On scholarships, she has studied Catalan philology at Universitat de Girona (Sócrates-Erasmus 2007–2008), Universitat de València (ESF DoRa 2009 y 2010) and Universitat de les Illes Balears (beca de perfeccionamiento de catalán del Institut Ramon Llull 2011).

LIINA LUKAS is Associate Professor of Comparative Literature at the University of Tartu and Senior Reseacher of the Estonian Academy of Sciences. She took her PhD with a theses "The Baltic-German literary field between 1880 and 1918" at the University of Tartu. Since 1998 she has taught comparative European and Estonian literary history. She has also worked as a visiting professor at the University of Vienna and has lectured at the universities of Göttingen, Helsinki and Latvia. She is the initiator and coordinator of the Digital Text Repository for Older Estonian Literature (www.utlib.ee/ekollekt/eeva), which offers access (with metadata in Estonian, German, English and Russian) to old cultural texts, written or published in the Baltic cultural space. She is a member of Doctoral school at the University of Latvia and Chairwoman of Goethe-Gesellschaft in Tartu. In 2011, she was awarded Vilis Vītols Award of AABS for the best article in the *Journal of Baltic Studies* and the annual article prize of the journal *Keel ja Kirjandus*.

VANESA MATAJC, PhD, is an Assistant Professor at the Department of Comparative Literature and Literary Theory (Faculty of Arts, University of Ljubljana). Her recent publications include a monograph [Reflections] Osvetljave on the contemporary Slovene novel (2000) and articles "The interaction between literature and theory from Romanticism to the fin de siècle = Interakcija literature in teorije od romantike do moderne" (Primerjalna književnost / Comparative Literature. Special Issue. 29/2006); "History and its literary genres = Zgodovina in njeni literarni žanr" (Primerjalna književnost / Comparative Literature. Special Issue. 30/2007).

ARNE MERILAI is Chair Professor of Estonian Literature (2011) of the University of Tartu, former associate professor of literary theory. At present, his primary area of research is national literature in the context of world literature informed by a comparative poetics and 'unified field theory' for literary studies. Primarily, his research is anchored in bio-bibliographical and comparative historical traditions, formal poetic analysis, linguistic and close-reading criticism, literary psychoanalysis and phenomenology. In addition, he has developed an innovative approach called 'pragmapoetics', a philosophy of poetic language usage rooted in analytical philosophy. His book Eesti ballaad 1900–1940 (The Estonian Ballad 1900–1940) was published in 1991, and Eesti pagulaskirjandus 1944–1992: Luule (The Estonian Exile Literature 1944–1992: Poetry; together with Onne Kepp) in 1994. Eesti ballaad: Antoloogia: XVII–XX sajand (The Estonian Ballad from 17<sup>th</sup> to 20<sup>th</sup> Century: Anthology), Poeetika: Gümnaasiumiõpik (Poetics: Gymnasium Textbook; with Anneli Saro and Epp Annus), and Pragmapoeetika: Kahe konteksti teooria (Pragmapoetics: A Theory of Two Contexts) were released in 2003. He has published volumes of his own selected articles last year, Vokimeister: Kriitilisi konstruktsioone 1990–2011 (The Spinning Wheel Maker: Critical Constructions, 1990–2011), and Onne tähendus: Kriitilisi emotsioone 1990-2010 (The Meaning of Happiness: Critical Emotions, 1990-2010). A member of the Estonian Writers' Union, he is the author of two books of poetry, Merlini aare (Merlin's Treasure, 1998) and Tolmutort (The Dust Cake, 2001), a play (2006), and a novel Türann Oidipus (2009). With about 250 publications to his credit, professor Merilai ranks among the most prolific literary scholars in Estonia.

EMILIA PARPALĂ is Professor at the Faculty of Letters, University of Craiova, since 1975. Her academic interests include stylistics, poetics, semiotics, imagology and verbal communication. Between 2009 and 2011 she coordinated a research project on Romanian postmodern poetry, approached with a complex interdisciplinary methodology. She initiated and coordinated four editions of the international conference Comparativism, Identity, Culture and co-edited four volumes. Her PhD thesis, Poetica lui Tudor Arghezi. Modele semiotice și tipuri de text (Tudor Arghezi's Poetics. Semiotic Models and Text Types), 1984, pioneered the practice of generative poetics in Romania. Poezia semiotică. Promoția '80 (The Semiotic Poetry. Promotion of the Eighties), Craiova, 1994, is a small book constructed on the idea of isomorphism between (semiotic) theory and the literary practice. The main topics have been reconsidered in her 14 articles in the volume she coordinated in 2011, Postmodernismul poetic românesc. O perspectivă

semio-pragmatică și cognitivă (Romanian Postmodern Poetry. A Semio-pragmatic and Cognitive Perspective). She is the author of four theoretical synthesis: Comunicarea verbală (The Verbal Communication), 2009; Semiotica generală. Pragmatica (General Semiotics. Pragmatics), 2007; Introducere în stilistică (Introduction to Stylistics) - three editions (1998, 2005, 2006); Poetica. O introducere (Poetics. An Introduction), 1998. More than 100 articles have been published in academic magazines in Romania and abroad (by De Gruyter, John Benjamins) and in the proceedings of international conferences. Since 2010 she is the vice-president of the Romanian Association for Semiotic Studies (ROASS). e-mail: parpala\_afana@yahoo.com.

SILKE PASEWALCK is an associate professor at the German Department at Tartu University. She earned her doctoral degree in German literature in 2002 for a monograph about the relation between poetics and perception (Rainer Maria Rilke) at Freie University Berlin. Her scholarly work falls into the following areas: literary interculturality, literature and nation building, literature and dictatorship, literary and cultural didactics for German as a foreign language. In 2011 she has published a volume together with scholars form Estonia and Germany about national epics in a comparative perspective: *Nationalepen zwischen Fakten und Fiktionen*, co-edited with Heinrich Detering, Torsten Hoffmann and Eve Pormeister. She has organized an International Conference at Tartu University about "Interculturality and literary translation" (2011).

AUDINGA PELURITYTĖ-TIKUIŠIENĖ's scholarly work falls into the following areas: classical and modern poetry (from Maironis, to Martinaitis and Marčėnas), contemporary Lithuanian literature (modern and postmodern prose, poetry, essay), feminist researches in Lithuanian literature, theoretical researches. She has studied Lithuanian and East and Central European Literature at Vilnius University (BA in 1995, MA in 1996). She wrote her doctoral thesis, 'Lietuvių lyrikos tradicija: struktūrinės dominantės Maironio, Vinco Mykolaičio-Putino, Salomėjos Nėries, Jono Aisčio ir Henriko Radausko kūryboje' [Tradition of Lithuanian Lyrical Poetry of the 20th Century: Structural dominance in the lyric of Maironis, Vincas Mykolaitis-Putinas, Salomėja Nėris, Jonas Aistis and Henrikas Radauskas] at Vilnius University (PhD awarded in 1999). She is currently associate professor at Vilnius University. In 2006 she published a book about modern Lithuanian literature: Senieji mitai, naujieji pasakojimai: apie naujausią lietuvių literatūrą [Old Myths, New Tales: About Contemporary Lithuanian Literature]. She has organized

two International Contemporary Literature Conferences at Vilnius University, in 2005 and 2008.

MELE PESTI is lecturer of Brazilian literature at Tallinn University. She is currently pursuing doctoral studies in the field of Brazilian modernism, focusing on the cultural metaphor of anthropophagy. Her research interests lie in the Lusophone world, translation studies, post-colonial theory, Latin American and Portuguese literature. She has worked as a cultural journalist and has co-translated *Cidade de Deus* by Paulo Lins from Portuguese to Estonian. She has also written a travel book, *Mate ja miljon mahla* (2009).

LAURI PILTER earned his PhD degree in English language and literature at the University of Tartu with the monograph *The Comic and the Tragicomic in the Works of William Faulkner* in 2009. Since 2007, he has been lecturing about comparative literature at BA and MA levels at Tartu University. A Researcher of Comparative Literature since 2010, his fields of interest include the literatures of European ethnic minorities/minor ethnicities, twentieth century Western novel, mediaeval and Renaissance verse traditions, and the history and characteristics of the translations of Estonian poetry into English. His translations into Estonian include British, Italian and Provençal poetry, three novels by Cormac McCarthy, two novels by Philip Roth, short fiction by William Faulkner, a novella by Thomas Wolfe and an autobiographical novel by Mark Twain. Author of the novel *Lohejas pilv* (A Dragon Cloud, 2004) and the collection of fiction *Retk Rahemäkke* (A Journey to the Hail Mountain, 2010), winner of the Fr. Tuglas and B. Alver awards for fiction in 2004.

CARMEN POPESCU is Senior Lecturer, PhD, at the University of Craiova, Romania, Department of Romanian and Classical Philology. She teaches general and comparative literature, and optional courses, including one on intertextuality. In 2002 she defended her thesis in philology, entitled Scriiturile diferenței. Intertextualitatea parodică în literatura română contemporană (The Writings of Difference. Parodic Intertextuality in Romanian Contemporary Literature). The thesis appeared in book-form in 2006. She has published a number of articles on comparative literature, intertextuality, parody, and the reception of classical themes in modern and postmodern literature. She has coedited two editions (2009 and 2010) of the Proceedings of Comparativism, identity, communication, an international conference organized by University of Craiova. She was a member in the research project Romanian Poetic Post-

QI CHEN is a PhD candidate in Italian language and literature in Scuola Normale Superiore di Pisa, Italy. Her main research interest is Italian literature, Chinese literature and their comparative aspects. She has published several articles on the physiognomy in Italian autobiography, in Chinese historical novels and has also published some on Italian authors in order to present them to Chinese academia.

MARIS SAAGPAKK received her PhD in Baltic-German literature from Tallinn University in 2007. She is currently Associate Professor of German literature and cultural studies at the Institute of Germanic and Romance Languages and Cultures of Tallinn University. Her main academic fields are the history of Baltic-German literature, life writing, cultural transfer and post-colonial studies. The most recent publications concern the patterns of colonialism established by the Baltic-Germans in Estonia, Baltic-German autobiographic texts from 17<sup>th</sup> century and autobiographies of Baltic-German women.

JÜRI TALVET is since 1992 Chair Professor of Comparative Literature at the University of Tartu. He took his PhD on the Spanish picaresque novel at Leningrad University in 1981. He has published in Estonian collections of essays Hispaania vaim (The Spanish Spirit, 1995), Tõrjumatu äär (The Irrefutable Edge, 2005), cultural-philosophic reflections Sümbiootiline kultuur (Symbiotic Culture, 2005), books of (travel) essays Teekond Hispaaniasse (1985, Estonia's annual literary prize in essay genre), Hispaaniast Ameerikasse (1992), Ameerika märkmed ehk Kaemusi Eestist (2000) and eight books of poetry. His books of poetry and essays have been translated into English, Spanish, French, Catalan, Romanian and Italian. In 1997 he was awarded the Juhan Liiv Prize of Poetry and in 2002 the Ivar Ivask Memorial Prize for poetry and essays. He has translated into Estonian both classical and modern works (Quevedo, Gracián, Calderón, Tirso de Molina, Espriu, Aleixandre, García Márquez, etc.) and has edited a major anthology of US poetry in Estonian translation (2008). He is the editor and principal author of a manual of world literature for Estonian high schools and universities (Maailmakirjandus, I-II, Tallinn 1995–1999). In 2012 his monograph on Juhan Liiv's poetry (Juhan Liivi luule) was published. He has chaired the Estonian Association of Comparative Literature (1994–2010) and has also served as member of the ICLA Executive Committee (2000–2007).

KATRE TALVISTE has a PhD in comparative literature from the University of Paris 12 - Val-de-Marne (2007). At present she is teaching Estonian language and culture at the National Institute for Oriental Languages and Civilisations in Paris and is in postdoctoral studies at Tartu University. Her main research interest is the history of translation. She has translated texts of Marcel Gauchet, Thomas Pavel, Paul Ricoeur, Michel Foucault, Alain Besançon into Estonian, has published several articles, as well as various texts on French authors for secondary school textbooks and other didactic editions.

KWOK-KAN TAM is currently Chair Professor and Dean of Arts & Social Sciences at the Open University of Hong Kong. He received his PhD in Comparative Literature from University of Illinois at Urbana-Champaign. He was Post-doctoral Fellow and then Fellow at the East-West Center, Honolulu in the 1980s, and then taught English and Comparative Literature at the Chinese University of Hong Kong for twenty years before he moved to the Open University. He has published widely on Ibsen, Gao Xingjian, comparative literature, modern drama, and world Englishes. Among his many books are Ibsen and the Modern Self (Acta Ibseniana VII), Gender, Discourse and the Self in Literature: Issues in Mainland China, Taiwan and Hong Kong (2010), Englishization in Asia: Language and Cultural Issues (2009), English and Globalization: Perspectives from Hong Kong and Mainland China (2004), Ibsen in China: An Annotated Bibliography of Criticism, Translation and Performance (2001), Soul of Chaos: Critical Perspectives on Gao Xingjian (2001), A Place of One's Own: Stories of Self from China, Taiwan, Hong Kong and Singapore (1999) and New Chinese Cinema (1998).

ANDREI TERIAN, PhD, is currently senior lecturer at the "Lucian Blaga" University of Sibiu. His area of expertise includes fields such as the Romanian literature (20<sup>th</sup> century), comparative literature, literary theory, the history of Romanian and European literary ideas in the 20<sup>th</sup> century. He is PhD of the Bucharest University (2008), with a thesis *G. Călinescu – His Theory and Method of the Literary Criticism and History*. He is the author of the volume *G. Călinescu: The Fifth Essence* (2009), which received several awards, among which the National Award of the Romanian Writers' Union and the Grand Prize "Prometheus" – Opera Prima. He contributed to several research projects of the Romanian Academy, such as *The General Dictionary of Romanian Literature* (7 vol., 2004–2009) and *The Chronology of the Romanian Literary Life:* 1944–1964 (3 vol., 2010). He attended two research stages in Italy and

Austria and has published until now approximately 40 articles in specialized journals and volumes in UK, France, Italy, Slovakia and Romania. Presently, he is the director of two research projects that study the relation between methodology and ideology in the configuration stage (1870–1930), respectively in the current stage (1965–2010) of the Romanian literary criticism and history.

TERRY SIU-HAN YIP is Professor in the Department of English Language and Literature at Hong Kong Baptist University. She received her MA and PhD from the University of Illinois at Urbana-Champaign, U.S.A. and has been teaching at HKBU since 1985. Her research interests range from European Romanticism and British Modernism to Chinese-Western literary relations and women/gender studies in Chinese and/or Western literature. She has published extensively on Chinese-Western comparative literature, women's writings, literature and cultural change in China, women and/or gender issues in literature, as well as the influence of European writers on modern Chinese literature. Her publications can be found in academic books and journals published in Australia, Bratislava, Canada, China, Holland, Hong Kong, Japan, Norway, Taiwan, and the United States. Her recent publications appear in Gender, Discourse and the Self in Literature: Issues in Mainland China, Taiwan and Hong Kong.
