His books of poetry and essays have been translated into English, Spanish, French, Catalan, Romanian and Italian. He has translated into Estonian both classical and modern works (Quevedo, Gracián, Calderón, Tirso de Molina, Espriu, Aleixandre, García Márquez, etc.) and has edited a major anthology of US poetry in Estonian translation (2008).
