RENÁTA BALÁZS is currently a doctoral student of folklore and literature of the Uralic peoples at Eötvös Loránd University in Hungary. In her thesis she investigates the writing of contemporary national literary history in Finland and Hungary. Her focus is on the main works of the national literary histories and the literature textbooks used in secondary schools. Besides dealing with literary studies she has translated some short stories from Finnish into Hungarian.

SARA BÉDARD-GOULET, PhD in Literary Studies, is ASTRA Professor of Romance Studies at the College of Foreign Languages and Cultures of the University of Tartu. Her main research interests in the field of contemporary French-language literature include reader-response theories; ecocriticism and geopoetics; literature and psychoanalysis. She has worked extensively on the novels of the French author Jean Echenoz and the novels, plays and autobiographical narratives by Quebec author Michel Tremblay.

SAMUEL BIDAUD is Assistant Professor of French at the University Palacký of Olomouc (Czech Republic). His research interests are Romance languages and literatures as well as Czech. He is especially interested in the works of Hergé, Marcel Proust, José Mauro de Vasconcelos and the Czech author Jan Čep.

CHEN DAHONG holds her PostDoc for drama and literature studies from Communication University of China, in Beijing. After visiting Estonia for the first time in 2013, in 2019/ 2020 she could spend on Estonian Archimedes Foundation scholarship five month in Tartu, researching and translating into Chinese works of Estonian literature.

CAIUS DOBRESCU is Professor at the Bucharest University (Theory of Literature, Cultural Studies). He has written on literature and politics in the Communist and post-Communist era and on the interaction between the conflicting understandings of the notion of "bourgeois culture" and the evolutions of the literary modernity, from a global comparative perspective. As a Fulbright scholar affiliated with the Committee on Social Thought of the University of Chicago, he conducted research on terrorism and literary

modernity. Currently, he takes part in the European research project Detecting Transcultural Identity in European Popular Crime Narratives – DETECt (detect-project.eu).

DAIANA GÂRDAN is a PhD Candidate at the Department of Comparative Literature at the Faculty of Letters, Babeş-Bolyai University, in Cluj-Napoca and assistant editor of the *Metacritic Journal of Comparative Studies and Theory*. She authored several studies employing quantitative methods on the Romanian modern novel, as well as transnational perspectives on the literary canon.

DRAGOS JIPA, PhD in history and civilizations at the EHESS Paris (2012), is Lecturer (tenured) at the Department of French Language and Literature of the University of Bucharest. After having studied in his thesis the canonization of literature in 19th-century France, published as *La canonisation littéraire et l'avènement de la culture de masse. La collection « Les Grands Ecrivains Français »* (1887–1913) (Peter Lang, 2016), his current research interests are the teaching of French literature in Romania and the French cultural diplomacy, in the larger context of the history of humanities.

AUŠRA JURGUTIENĖ, PhD in Humanities, is a senior scholar in the Department of modern literature at the Institute of Lithuanian Literature and Folklore in Vilnius. She has more than 80 Lithuanian and international publications and is the author of two monographs: Naujasis romantizmas iš pasiilgimo: lietuvių neoromantizmo pradininkų estetinė mintis (New Romanticism from Longing: The Aesthetic Thought of the Founders of Lithuanian New Romanticism, 1998) and Literatūros suvokimo menas: Hermeneutikos tradicija (The Art of Literary Interpretation: The Hermeneutical Tradition, 2013). Jurgutienė was the chief editor and co-author of the academic textbook XX amžiaus literatūros teorijos (20th-Century Literary Theory, v. 1 – 2006, v. 2 – 2010, v. 3 and 4 – 2011) and co-editor of the volume Literary Field under the Communist Regime: Functions, Structure, Illusion (Academic Studies Press, 2019). Her research interests are 20th-century literary history and literary theories of the 20th century (hermeneutics, reception, deconstruction, comparative literature).

MARCIN KLIK, PhD with habilitation, is a researcher at the University of Warsaw, Poland. He is the author of several books and articles on modern French, Swiss and Polish literature as well as literary theory. In his essays on poetry and prose, he combines psychoanalytic and thematic criticism, involving themes understood as individual, hidden, concrete "signified" expressing the

affective relation of the writer with the external world. The subject of his latest book is relationship between myth and literature.

MATIC KOCIJANČIČ is a doctoral student of comparative literature at the University of Ljubljana. His primary research interest is the reception of Greek tragedy in modern literature, philosophy, and theatre.

TANEL LEPSOO teaches French literature at the University of Tartu. After defending his PhD on contemporary French theatre, he has primarily worked on the visual modes of representation in fictional words as well as in the cultural and political sphere. His research focuses on the prose of the first half of the 20th century and the drama of the 1990s. He analyses social images and mental representations, above all in connection with different emotional phenomena. He has also worked with Estonian authors with close ties to French culture.

JINJIN LU, PhD, is Associate Professor in the Faculty of Foreign Languages at China University of Geosciences (Wuhan) and Research Fellow in the Institute of School of Education at Masaryk University in the Czech Republic. She was a researcher in Charles Sturt University and Western Sydney University for years in Australia. She is passionate and interested in using autoethnography as a methodology in literacy, childhood education and cultural studies. Her recent work has been published by Reflective Practice, Cultura y Educación, and Ethnography and Education.

VERA MENIAILO is Associate Professor of Foreign Languages Department, National Research University Higher School of Economics, St. Petersburg, Russia. In 2010 she defended her PhD dissertation on the topic: "Evolution of Concept of FREEDOM Characteristics and Means of Language Representation in J. Fowles Works". In the subsequent year she published a book on the related topic in the Russian language: "Evolutia kartiny mira avtora v proizvedeniyah Faulza" ("Evolution of the author's picture of the world in the works of J. Fowles"). Among her research interests are stylistics and text linguistics, history of the English literature and comparative literary studies.

ARNE MERILAI is Professor and Chair of Estonian Literature (2011) at the University of Tartu. His primary area of research is national literature in the context of world literature informed by a comparative poetics and unified field literary theory. He has developed an innovative approach called pragmapoetics, a philosophy of poetic language usage. His book *Eesti ballaad 1900–1940* (*The*

Estonian Ballad, 1900–1940) was published in 1991, and Eesti pagulaskirjandus 1944–1992: Luule (Estonian Literature in Exile 1944–1992: Poetry, with Õnne Kepp) in 1994. Eesti ballaad: Antoloogia: XVII–XX sajand (Estonian Ballad: Anthology: 17th–20th Century), Poeetika: Gümnaasiumiõpik (Poetics: Textbook for High School, with Anneli Saro and Epp Annus), and Pragmapoeetika: Kahe konteksti teooria (Pragmapoetics: The Theory of Two Contexts) were released in 2003. Besides editing the joint research volumes, he has published two books of his own selected articles, Vokimeister: Kriitilisi konstruktsioone 1990–2011 (The Spinning Wheel Maker: Critical Constructs 1990–2011, 2011), and Õnne tähendus: Kriitilisi emotsioone 1990–2010 (The Meaning of Happiness: Critical Emotions 1990–2010, 2011). A member of the Estonian Writers' Union, he has penned two collections of poetry, Merlini aare (Merlin's Treasure, 1998) and Tolmutort (Dust Bunny, 2001), a play (2006), and a novel Türann Oidipus (Oedipus the Tyrant, 2009). With about 300 publications to his credit, Arne Merilai ranks among the most prolific scholars in Estonia.

EMANUEL MODOC obtained his PhD at the Department of Comparative and Universal Literature at the Faculty of Letters, Babeş-Bolyai University, Cluj-Napoca, with a doctoral dissertation on the networks of east-central European avant-gardes. He is an assistant editor for the *Metacritic Journal for Comparative Studies and Theory* and a research assistant at the Sextil Puşcariu Institute of Linguistics and Literary History, part of the Cluj-Napoca Branch of the Romanian Academy. His research interests include the avant-garde of East-Central Europe and contemporary Romanian literature, literary theory and criticism.

ANNELI NIINRE (née KÕVAMEES), PhD in literary studies, thesis *Italy in Estonian Travelogues: Italian Capriccio by Karl Ristikivi and Madonna with a Plastic Heart by Aimée Beekman* (2008, Tallinn University), is a senior research fellow at the School of Humanities at Tallinn University. Member of the Centre of Excellence in Estonian Studies. Main research interests: Estonian literature, Estonian travel literature, imagological literary research, national images and stereotypes in literature. Member of the European Network for Comparative Literary Studies (ENCLS), Estonian Comparative Literature Association and International Comparative Literature Association (ICLA).

MARKO PAJEVIĆ took up a European funded Professorship of German Studies at Tartu University in January 2018 after being in post at the Sorbonne, Paris IV, at Queen's University Belfast as well as Royal Holloway and Queen

Mary, Universities of London. He has published widely on poetics, with three monographs (Celan, Kafka), five (co-)edited volumes and over fifty articles. In recent years, his work has focused on the development of a poetological anthropology and 'Poetic Thinking' (monograph 2012). Special Issues on Humboldt (FMLS 2017, 53/1), Meschonnic (CCS 2018, 15/3) and *The Meschonnic Reader* (EUP 2019) manifest his interest in 'Thinking Language'. See his website apt.ut.ee.

SIMON RADCHENKO, Bachelor of World Literature and PhD candidate at the University of Torino, Italy. His current research interests in literature is focused on the carnival culture traditions and contemporary trends of the literature process. Besides he is interested in the postmodern and postpostmodern literature and contemporary Ukrainian literature. He also works as archaeologist and studies Early Bronze Age Archaeology and Neolithic and Rock art science. Member of CISENP (International Scientific Commission on Research into the Intellectual and Spiritual Expression of Non-literate Peoples of UISPP)

PILVI RAJAMÄE, PhD, teaches English literature at the Department of English at the University of Tartu. Her research interests include English and Scottish literature, British social and cultural history, British art and architecture, the English country house and increasingly Estonian literature between the two world wars. She has published on Evelyn Waugh, Tom Sharp and John Buchan.

JÜRI TALVET, the founding editor of *Interlitteraria*, has worked since 1992 as Chaired Professor of World Literature at the University of Tartu. Since 2016 he is member of Academia Europaea. His recently published works include a book of short essays in Estonian, *Tundmised* ('Cognitions', U. of Tartu Press, 2019) and several books in English: *Yet, Love, Illumine Us* (poetry; trans. with H. L. Hix; Červena Barvá Press, US, 2018), *Ten Letters to Montaigne.* "Self" and "Other" (essay; trans. with H. L. Hix; Guernica, Toronto, 2019) and *World Literature, Comparative Literature and the* "Other" (monograph; Cambridge Scholars Publishing, 2019).

BEATRIZ VALVERDE is Assistant Professor at the Department of English Philology at Universidad de Jaén. She holds a Doctorate in English Philology (Literature) from Universidad de Jaén. In addition, she holds an MA in Spanish Literature from Loyola University Chicago. In both fields, she has published

several articles in various Spanish and international journals, many of them connected to the work of Graham Greene. Her main research interests are Literature and Cultural Studies in English and Spanish, Critical Humanism in the Teaching of Humanities and Literature in Pre-College, Teaching of English as a Foreign Language.

BEATA WALIGORSKA-OLEJNICZAK is a University Professor and the head of the Department of Comparative Studies in Literature and Culture at Adam Mickiewicz University in Poznan (Poland). In 2004–2005 she studied Postmodern Cinema, American Theatre and Drama, 20th Century Art at Northwestern University (IL, USA).
